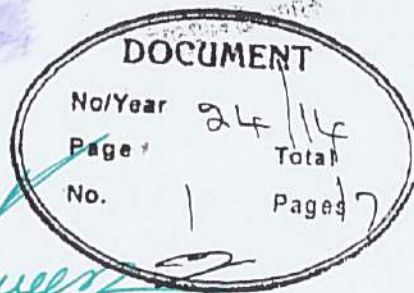

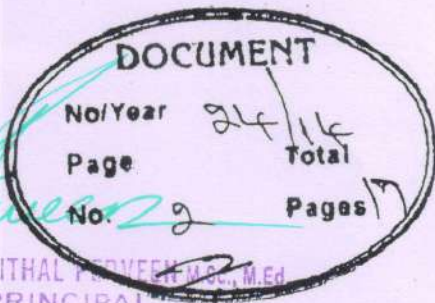

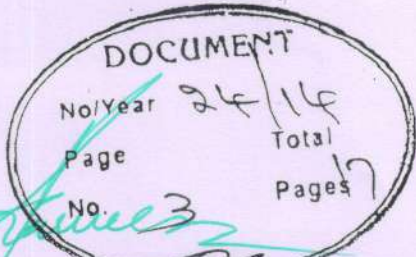

II. ADDRESS OF THE TRUST:

The Registered Office of the Trust shall function at Door No.1&2, Seikul Akbar Street, Melapalayam, Tirunelveli-627005. At present the Offices functioning in the above said address are in rent basis.

III. AREA OF OPERATION:

At present the trust shall operate with in the State of Tamilnadu and the area may be extended by the Board of Trustees through out the country on need based activities. It is further stated that the operation and activities of the Trust is limited within India.

IV. NATURE OF THE TRUST:

The Trust is secular and non-Profitable in nature. It is Public Charitable Trust carrying out only welfare and development activities to all the citizens of India without any discrimination of religion, race, sex, caste, creed etc. The Trust so formed shall be irrevocable.

V. OBJECTIVES OF THE TRUST:

1. To start a CBSE School in the name of Al Madinah Public School.
2. Primarily to establish educational Institutions such as Modern School / CBSE School and Colleges of all types and other educational institutions including libraries for minority students.
3. To establish orphanages, boarding and lodging houses for students.
4. To take over Schools and Colleges of all types from other organizations and Trusts.
5. Particularly to establish and run education related schools institutions, colleges, industrial and technical colleges, Medical Institutions and Training Center for the benefit of ^{all Community} minority students.
6. To institute awards, scholarships in India for study, research and apprenticeship and for helping poor students.
7. To carry out the following educational and enrichment activities:
8. Giving necessary Tuition, Coaching, etc., to the students who are studying Higher Education, training centers etc.,

18. Conducting various competitions and competitive examinations on all subjects concerned, among the students.
19. Giving Scholarships to the poor children and to help them in their higher studies.
20. To afford relief to people in distress due to natural calamities.
21. To grant the donations for the support of other needy Public Educational Institutions.
22. To carry on community development programmes for the uplift of the economically weaker sections.
23. To start tailoring units and free tailoring and all types of training to the poor women.
24. Conducting free Medical camps / Free Eye camps & Blood donation in rural areas.
25. To give necessary guidelines and helping to the cardiac diseases. (Heart failure), Kidney failure, Blood cancer, chronic diseases etc.,

VI. CONSTITUTION AND MANAGEMENT SYSTEM OF THE TRUST

The trust shall be solely constituted and managed by a Board of Trustees which has been entrusted with the following organizational and operational system.

1. Constitution of Board of Trustees:

The Board of Trustees will be constituted by the 3-Authors of the Trust with not less than 19 trustees and not more than 40 trustees.

The Author of the Trust/Managing Trustee has the power to appoint new Trustees and remove the existing Trustees with the consultation and consent of the Board Trustees. The Trustees shall hold office for their lifetime as long as they have normal mental and physical health. Further, the lifetime membership will be in action unless the Trustees resign or be removed.

The appointment and removal of Trustees will be issued by the Author of the Trust / Managing Trustee in writing. The Trustees shall be removed from the office normally for the Misconduct or breach of trust by acting against the objectives of the Trust. The removal order will be issued by the Author of the Trust/Managing Trustee bypassing a resolution by a majority in the Board of Trustees.

2. Administration of the Trust:

The Er.S.K.SYED AHAMED - Founder and Author of the Trust shall be the Managing Trustee of the Trust.

The Managing Trustee will be elected every Three Years by the Board of Trustees.

The general administrative power is entrusted with the Managing Trustee subject to the control and supervision of the Board of Trustees. The Managing Trustee shall adhere the following procedures for effective administration of the Trust.

3) The meetings of the Board of Trustees will be convene by the Managing Trustee at least once in every six months and at least two such Meetings shall be held within one financial year.

The Managing Trustee will be the Chairman of the Meetings of the Board of Trustees. In his absence the meeting will be chaired by any one of the Trustee as authorized by the Managing Trustee.

Questions arising at Meetings shall be decided by a majority of votes and in case of an equality of votes, the Chairman of the Meetings shall have a casting vote. Three of the Trustees shall be the quorum for the meetings.

All the resolutions and the proceedings of the meetings of the Board of Trustees will be recorded into the Minutes Book provided for the purpose and these minutes will be signed by the Trustees presented in the Meetings. The counter sign made by the Chairman of the meeting under the minutes recorded will be the prima facie evidence of the matters stated in such minutes.


ii) There shall be proper books of accounts such as cashbook, ledgers, receipt book, Voucher file etc.

The trustee shall assist the Managing Trustee for maintaining the proper books of accounts. The accounts must be audited by a qualified Chartered Accountant for each financial year and must be placed before the Board of Trustees for approval of the same. The financial year of the Trust will be 1st April to 31st March.

iii) The Managing Trustee will be the Chief Functionary of the trust. Thus he is empowered to give direction in regard to the business of the trust. He is authorized to sign in any documents, bonds, agreements, settlements etc. On behalf of the Trust. He is also authorized to sue or to be sued on behalf of the Trust.

iv) The Managing Trustee may constitute any special committees, advisory boards etc. in consultation with and consent of the Board of Trustees for some specific activities of the Trust. On behalf of the Trust, in consultation with and consent of the Board of Trustees, the Managing Trustee may select and recruit employees (part time / full time) for projects and administrative purposes.

Thus the Managing Trustee has been entrusted with administrative responsibilities towards achieving the objects of the Trust with the support, consultation and supervisory services by the Board of Trustees.

Amendments to the Trust Deed:

- i) Any particular clauses of the Trust Deed may be amended and new clauses may be inserted in to the Deed of Trust by the Board of Trustees subject to the following three conditions.
- ii) It would not extend to alter the basic character/ objects of the Trust. No such amendments shall be made which may prove to be repugnant to the provision of section 2(15),11,12 & 13 and 80G of the Income tax Act 1961.
- iii) Any amendment will be carried out only with the prior approval of the commissioner of Income Tax, Madurai.
- iv) The Managing Trustee Empowered to Register the Amendment Deed.

MANAGEMENT OF ACCOUNTS AND UTILISATION OF TRUST FUNDS:

1. Financial year of the Trust. The financial year of the Trust shall be from 1st April to 31st March.

Bank Accounts

The Accounts of the Trust will be managed through opening and operating bank accounts in the name of the Trust in any banks to be jointly operated with Managing Trustee & any one of the Trustee. Any amount exceeding Rs.1000/- (which is being kept for immediate disbursement) will be deposited and saved in bank accounts.

Auditing

The accounts of the Trust will be audited at the expiry of each financial year by qualified Chartered Accountant and Receipts and Payments Accounts, Income and Expenditure statement and Balance Sheet of the Trust will be prepared and placed for the approval of the Board of Trustees.

Funds of the Trust

The Income/ funds of the Trust will be raised through the following means:

- a) By receiving contributions from Trustees.
- b) By grants/ donations from individuals, organizations, governments and others within and outside India.
- c) By receiving advances and loans from individuals, organizations, Government Departments and others with in and outside India – with or with out interest / security.

By raising supplementary income through productive units/economic activities / service charges of the assets and resources of the Trust (which are to be run in the spirit of enhancing over all public welfare and satisfying the conditions prescribed in section 11(4) and proviso to section 80G of the Income Tax Act 1961).

5. Utilisation of the Funds :

a) The income / funds of the Trust will solely be utilized towards the objects of the Trust - (ie) for Welfare and Development activities for the poor needy marginalized and weaker sections. No portion of it will be utilized for the payment to the Trustees by the way of profit / dividend / interest / honorarium / salary / compensation. The Trustees should not claim any remuneration for their services in the capacity of a Trustee, but the Trustees may be remunerated for their technical / professional services to the Trust besides the capacity of Trustees. The Trustees can also claim the actual travel or other boarding / lodging expenses if they are spent for the purposes / activities of the Trust.

b) Any purchases made by the funds of the Trust must be in the name of the Trust. Any purchase or sale made by the Trust must be carried out in the presence of Managing Trustee and prior approval must have been obtained from the Board of Trustees for such transaction.

c) While utilizing the funds of the Trust towards the objectives and activities of the Trust, if the income exceeds the expenditure, the surplus fund can be saved as Corpus Fund/ Capital Fund/ other specific fund.

d) The investments of the funds of the Trust shall be in accordance with the provision of section 11(5) read with section 13(1) (d) of the Income Tax Act 1961.

e) In the event of dissolution of winding up of the Trust, the assets remaining as on the date of dissolution / winding up, shall under no circumstances be distributed among the Trustees but the same shall be transferred to another charitable trust / society/ organization having similar objects and enjoying recognition under section 80G of the Income Tax Act 1961.





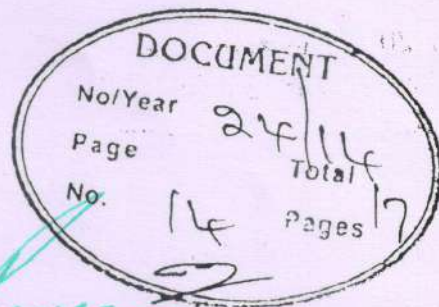
